Onsite Private Events Package

The Monterey County Fair Heritage Foundation's mission is to raise funds through grants and special events to support the functions of, capital improvements to, and scholarships through the Monterey County Fair & Event Center. The Monterey County Fair Heritage Foundation holds the exclusive beverage services contract with the Monterey County Fair & Event Center. Our bartenders are available for all of your beverage service needs.



Bar Service

- All bar packages are based on a 5 hour minimum.
- Standard costs of booking which must be paid before the start of the event include:
 - \$100 bar set up per bar
 - Bartender Fee of \$175 per bartender
 - Plus \$20 per hour after 5 hours
- There are many bar service packages that will fit your event needs and budget.
 - Open Bar
 - Partial Host
 - No Host/Cash Bar

Host/Open Bar Package

- Renter is responsible for the total amount of alcohol sold at the event in addition to a 15% gratuity.
- All beer must be consumed onsite; no refunds will be given for any product not consumed.
 - Domestic \$300/Keg
 - Imported \$350/Keg
- Renter will provide a credit card that will be charged at the close of the event to cover the costs.
- The Foundation Coordinator will provide a credit card authorization form that will stay on file.

Partial Host Bar Packages

- **Option 1:** Renter may place a cap amount that guests may drink. Once that amount is reached the bar becomes “no host”.
- **Option 2:** Renter may choose to host wine and beer sales. Liquors will be considered “no host”.
- **Option 3:** Hosted Keg – Renters may pre-purchase kegs to serve hosted. The remaining bar will be considered no host.
 - Domestic - \$300/Keg
 - Imported - \$350/Keg

No Host Bar Package

- The event will be a cash bar in which the guests will be charged per individual drink.

Additional Services

- **Champagne Toast Package** – \$8.00 per glass
 - The Renter will pay per bottle for this service.
 - The amount will be due with the standard bar fees prior to the event.
- **Corkage Fee** - \$8.00 per bottle
 - Wine that is not available through one of our distributors may be brought in by the Renter.
 - The number of bottles must be pre-approved by the Foundation Coordinator.
 - The bottles must be delivered to the Foundation Coordinator on the day of the event.
 - The final amount will be charged to the card on file at the close of the event.

HARD LIQUOR MAY NOT BE BROUGHT ON SITE

Specialty Drinks

A specialty drink is any unique or original drink that expresses the nature of the person or establishment creating it.

When booking an event with the MCF Heritage Foundation you have the opportunity to work with the Foundation Coordinator to build a drink that reflects your event.

The Signature Drinks may be hosted by the Renter based on the amount of drinks requested.

Some ideas include:

- A mixed drink reflecting the bride & groom
- A cocktail showcasing the theme of your event
- A shot that is named after an honored guest

Liquor Policy

Monterey County Fair & Event Center does not allow alcoholic beverages of any kind to be brought into the banquet/meeting rooms or outside on the grounds (within the property fence). All wine, beer, & liquor sales must be provided by the MCF Heritage Foundation. It is unlawful for any person(s) or organization(s) to bring alcoholic beverages on these premises; **liquor shall be confiscated and a fee of \$500 will be charged to the RENTER'S AGREEMENT.**

Alcohol Consumption & Liability

In order to protect the safety of your guests and others, Monterey County Fair Heritage Foundation reserves the right to deny service of alcoholic beverages to anyone. We may also, at our discretion, cease alcohol service entirely if it is deemed appropriate. Alcoholic beverage service will end no less than an hour prior to the scheduled end time of the event. The host(s) of all privately contracted events will be held responsible for their guest's behavior. Children in attendance must be supervised by adults.
