City of Monterey Business Licenses for 7th District Agricultural Association, Monterey **County Fair Contractors**

Dear Mr. Pizzo:

I am responding to your letter dated September 6, 2018 (enclosed) on behalf of my client, the 7th District Agricultural Association ("DAA"), also known as the Monterey County Fair. The California Department of Food & Agriculture ("Department") Fairs & Expositions Branch ("Branch") provides policy and fiscal oversight of District Agricultural Associations ("DAAs"). The Department's Legal Office serves as counsel for the Branch and DAAs throughout the state.

It is your position that the 7th DAA's contractors must obtain a City of Monterey business license pursuant to Monterey City Code, Chapter 19, Section 19-4. The local ordinance requires any person to procure a license before transacting any business in the City of Monterey.

After review of the 7th DAA contracts, I determined that these contractors are not subject to the City of Monterey's business license requirement. A DAA, as a state entity, is immune from local regulations when operating within its governmental capacity. (Bame v. City of Del Mar (2001) 86 Cal.App.4h 1346, 1356.) When determining whether a DAA's immunity extends to its contractors, "the relevant inquiry is whether [a DAA] acts within its governmental capacity in contracting with these entities." (Id. at 1355.)

The 7th DAA's purposes are to hold fairs and expositions to promote all the state's industries products and resources, and constructing, maintaining and operating recreational and cultural facilities for the public. (Food and Agricultural Code § 3951). To carry out these functions, it is necessary for the DAA to contract for services. These contracts include services such as marketing and entertainment for the annual fair, administrative and operational support, and construction and repairs for the fairgrounds. Contracting for these services is within a DAA's governmental capacity.



The sovereign immunity possessed by the 7th DAA in holding its annual fair and other events, as well as constructing and maintaining its facilities, extends to its contractors. The 7th DAA and its contractors are therefore exempt from the City of Monterey's business license requirement. Please feel free to contact me if you would like to discuss further.

SUBJECT: Upcoming Reporting Change for Government Compensation in California

Dear Chief Executive Officer:

This letter is to remind you of an upcoming change to the 2018 Government Compensation in California (GCC) reporting requirements. A previous notification letter outlining the change should have arrived in your office by last January. We are sending this additional letter to allow your office sufficient time to prepare for the change.

Beginning with the 2018 reporting year, employers will be required to report only the normal pension cost in the "Defined Benefit Plan: Employer's Share" column. Unfunded liability payments must be excluded. The goal of this change is to facilitate consistent reporting and improve the comparability and transparency of the compensation information published on the GCC website.

The GCC reporting template and instructions reflecting this change will be available on the State Controller's Office website in early 2019 when the annual alert letters are mailed.

Director Short made a motion to approve the agenda; seconded by Director Tran and it passed unanimously.

Consent Agenda

A. The minutes of the November 1, 2018 meeting along with Interim/Judges, Standard and Concession Agreements and approval of October bills were approved upon a motion/second from Director Thompson/Short; motion carried.

Fair CEO Report / Staff Reports

Violini reported that she and staff member Wygal attended Manager's Conference in Sacramento for two days. There were many state updates as well as customer service/leadership trainings. Staff will be attending WFA Convention in Reno from January 20-23.

New Business

- A. Nominating Committee Report and Approval of 2019 Officers: Directors Byrne and Lindley met and is proposing the slate of officers for 2019: Paul Tran for President and Teri Short for Vice President. Approved upon a motion/second from Directors Thompson/Cabrera; motion carried. President Boyles thanked Directors Lindley and Byrne.
- B. 2019 Committee Selection: Violini distributed the committee sheet for all board members to complete. This will be approved at the January 2019 board meeting.
- C. Approve updated RV Rates: President Boyles presented the RV Rate updates from 2019-2023. In 2019, regular pricing is \$55/night and large events are \$75/\$100 for US Open with a 4-night minimum. In 2020, regular pricing will increase to \$60/night while large events stay the same. From 2021-2023, all rates will increase \$5 annually. Approved upon a motion/second from Directors Thompson/Short; motion carried.
- D. Approve SWF Admission Rates: Violini presented the proposed Race Place pricing. It is now \$7.00 and big races are \$10.00. Proposal is to increase to \$8/\$11 in 2019 and 2020; \$9/\$12 in 2021 and 2022 and \$10/\$12 in 2023. Night racing pricing is proposed to be \$3.00 from 2019-2022 and \$4.00 in 2023. Violini explained that the night racing admission pricing is new and will be charged after 3:30 PM daily. Directors Short/Vivien moved to approve the increases in daily admission from 2019-2023 and approve pricing for night racing for Quarter 1 in 2019 then review in April. Vote passed unanimously.
