



2023 Monterey County Fair Mutton Bustin'

This event will be held during the **MONTEREY COUNTY FAIR** on Friday, September 1st at 6:30 PM, Saturday, September 2nd at 6:30 PM, & Sunday September 3rd at 3:00 PM and 6:30 PM. It is open to any child in Monterey and surrounding counties between the ages of 4 & 7 and weighs 60 pounds or less. The entry fee is \$10.00 per child. Must show proof of health insurance and a birth certificate to enter.

Please submit ALL documents together by mail, no later than August 1st, 2023. This includes a birth certificate, proof of insurance, entry form, release, and payment (cash or check). Entries submitted with any missing forms will not be considered valid. If you are submitting a check, please list in the description portion of the check "Mutton Bustin' for CONTESTANT NAME". Entries may also be submitted at the admin office on the fairgrounds, no later than August 1st, 2023.

Each entry will receive 1 adult ticket and one child's ticket to the rodeo. This entry DOES NOT include fair admission. Please find the URL below to purchase your fair admission tickets *pre arrival*. Each child may have one helper in the arena. Please bring a helmet with you. Please report to the **back of the arena by Gate 6** at least 30 minutes prior to the show (by 6:00PM for a 6:30 PM show or 2:30 PM for the Sunday 3:00 PM show). Each child will receive a prize after they ride.

THIS EVENT WILL BE AT THE START OF EACH PERFORMANCE. WE WILL NOT BE RESPONSIBLE IF YOU SHOW UP LATE.
