IMPORTANT DATES & DEADLINES

Please refer to your sponsorship agreement for payment due dates.

- 1. July 1st: Please submit payment and sponsorship agreement by this date.
- 2. <u>July 15th:</u> This is the last day to send logos to media@montereycountyfair.com, or upload logos to the sponsorship form, for inclusion in all fair marketing. Sponsorship gifts and tickets will be delivered this week.
- 3. <u>August 16th:</u> If your sponsorship package includes Kick-Off BBQ Tickets, this is the last day to RSVP to the event.
- 4. <u>August 13th or Prior:</u> Banners must be delivered to the Monterey County Fair office at 2004 Fairground Rd.
- 5. Sept 2-5th: Banners may be picked up from the fair office.

BANNER SIZES AND DELIVERY

For ALL Sponsors: Vinyl Banners should be no larger than **3x8**. Depending upon location, 2-sided banners may increase audience exposure. Banners must include grommets, and banners without proper grommets risk the inability to be hung up by fair staff. Please drop off your banners no later than Friday, August 16th at the main office of the Monterey County Fairgrounds. The office is located at the corner of Fairgrounds and Garden Road, and office hours are from 9-12, and 1-5 daily. Banners will be installed and removed by fair staff. Banners may be picked up after the closure of the annual fair, beginning Sept. 2nd.

SPONSOR TICKETS, CREDENTIALS, AND PASSES

A package with all fair tickets and parking passes included in sponsorship will be mailed out to each sponsor on or the week of July 14th. Sponsors who receive an on-site booth will receive a separate vendor package with additional details. SPONSOR BOOTH SET-UP

If your sponsorship agreement includes a booth space, a separate 'Vendor Handbook' will be sent to you with all rules, regulations, and FAQ's necessary and pertaining to having a space during the Monterey County Fair. Unless prior arrangements have been made, all rules and regulations will apply to sponsors who may have a booth on site. If you have a day *media* sponsorship, your booth and banners must be removed by 6:00 p.m. If you have an evening media sponsorship, your booth may not be set up prior to 6:00 p.m. and must be removed by 10:00 p.m.

Many sponsors will have the opportunity to place an advertisement in one of our weekly enewsletters to fair patrons, depending on level of financial sponsorship.
